4	This title applies only in Prince George's County.

6	(a) There is a family entertainment permit.
7 8	(b) The Board may issue the permit to a holder of a Class B (on-sale) license in accordance with this section if the Board determines that:
9	(1) the license holder's business provides family entertainment;
10 11	(2) the room in which the entertainment is to be provided has a seating capacity of not more than 110 individuals;
12 13	(3) the establishment will allow underage persons to view the entertainment and will not offer entertainment for adults only;
$14\\15$	(4) the average daily receipts from the sale of food will be at least 60% of the total daily receipts from the sale of food and drink in the establishment;
16 17 18	(5) the establishment will offer the same menu, including appetizers, main courses, and desserts, throughout the establishment and during the time when the entertainment is provided; and
19 20 21	(6) the prices for food and drink in the room where the entertainment is to be provided will not vary from the prices for food and drink offered elsewhere in the establishment.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July10 1, 2020.
