1 AN ACT concerning

2 **Prince George’s County – Alcoholic Beverages – Sunday Off-Sale Permits**

3 **PG 314–20**

4 FOR the purpose of repealing a limitation on the number of Sunday off–sale permits that
5 the Board of License Commissioners for Prince George’s County may issue; and
6 generally relating to alcoholic beverages in Prince George’s County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

1 **Article – Alcoholic Beverages**

2 26–102.

3 This title applies only in Prince George’s County.

4 26–1104.

5 (a) There is a Sunday off–sale permit.

6 (b) (1) (i) Subject to [subsection (f) of this section and] subparagraphs (ii)
7 and (iii) of this paragraph and except as provided in paragraph (2) of this subsection, the
8 Board may issue the permit to the holder of:

9 1. a Class A beer, wine, and liquor license; or

10 2. a Class B beer, wine, and liquor license with an off–sale
11 privilege.

12 (ii) Five Sunday off–sale permits may be issued only to holders of a
13 Class B beer, wine, and liquor license with an off–sale privilege that acquired the license
14 on or after January 1, 2016.

15 (iii) Sunday off–sale permits may be issued to holders of a Class A
16 beer, wine, and liquor license that acquired the license on or after January 1, 2016.

17 (2) The Board may not issue a Sunday off–sale permit to a license holder
18 that the Board finds to have sold liquor on Sunday without a Sunday off–sale permit.

19 (c) The permit authorizes the holder to sell alcoholic beverages for off–premises
20 consumption on Sunday from 8 a.m. to midnight.

21 (d) (1) Except as provided in paragraph (2) of this subsection, an applicant for
22 the permit shall commit in the application to reinvesting a minimum of \$50,000 in the
23 business within 1 year after the permit is issued.

24 (2) (i) The Board may waive the reinvestment requirement.

1 (ii) The Board shall waive the reinvestment requirement for a holder
2 of a Class B beer, wine, and liquor license with an off-sale privilege that acquired the
3 license on or after January 1, 2016, if the holder can show that a minimum of \$50,000 was
4 reinvested in the business within the 3-year period immediately preceding the submission
5 of the application.

6 (3) The Board shall revoke the permit if:

7 (i) the Board did not waive the reinvestment requirement under
8 paragraph (2) of this subsection; and

9 (ii) the permit holder fails to make the required reinvestment.

10 (e) If the permit is issued to the holder of a Class B beer, wine, and liquor license
11 with an off-sale privilege, the holder need not comply with any restaurant or food
12 requirement.

13 (f) [Not more than 105 Sunday off-sale permits may be in effect at any one time.

14 (g) (1) The application fee for the permit is \$750.

15 (2) The annual fees for the permit are:

16 (i) \$2,590 for the holder of a Class A beer, wine, and liquor license;
17 and

18 (ii) \$1,080 for the holder of a Class B beer, wine, and liquor license
19 with an off-sale privilege.

20 (3) The fees listed in paragraphs (1) and (2) of this subsection are in
21 addition to the annual fee for the Class A beer, wine, and liquor license or Class B beer,
22 wine, and liquor license to which it is attached.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2020.
