1 AN ACT concerning

2 **Prince George’s County – Public Safety Surcharge – Amount**

3 **PG 412–20**

4 FOR the purpose of providing that a certain Prince George’s County public safety surcharge  
5 amount is for certain residential housing constructed in an area included in a certain  
6 plan or an area that abuts an existing or planned mass transit rail station operated  
7 by the Washington Metropolitan Area Transit Authority or the Maryland Transit  
8 Administration, instead of requiring the surcharge to be for both areas; and generally  
9 relating to the public safety surcharge in Prince George’s County.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
4 That the Laws of Maryland read as follows:

5 **Article 17 – Prince George’s County**

6 10–192.11.

7 (a) The governing body of Prince George’s County, by resolution, may impose a  
8 public safety surcharge on new residential construction for which a building permit is  
9 issued by the County.

10 (b) (1) Except as provided in paragraph (3) of this Subsection, a public safety  
11 surcharge imposed on a single–family detached dwelling, town house, or dwelling unit for  
12 any other building containing more than a single dwelling unit shall be in the amount of:

13 (A) Six Thousand Dollars (\$6,000); or

14 (B) Two Thousand Dollars (\$2,000) for construction in:

15 (i) The Transportation Service Area 1, as defined by the  
16 Maryland–National Capital Park and Planning Commission in the Prince George’s County  
17 Approved General Plan; [and] **OR**

18 (ii) An area included in a basic plan or conceptual site plan  
19 that abuts an existing or planned mass transit rail station site operated by the Washington  
20 Metropolitan Area Transit Authority or by the Maryland Transit Administration and  
21 complies with the requirements of any sector plan, master plan, or overlay zone approved  
22 by the Prince George’s County District Council.

23 (2) The public safety surcharge does not apply to a single–family detached  
24 dwelling that is to be built or subcontracted by an individual owner in a minor subdivision  
25 and that is intended to be used as the owner’s personal residence.

26 (3) The governing body of Prince George’s County may waive any  
27 surcharge imposed under subsection (b)(1)(B) of this Section.
