4 FOR the purpose of altering the boundaries of the school board districts for election of the
5 members of the Prince George’s County Board of Education; and generally relating
6 to the school board districts for the Prince George’s County Board of Education.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

2 (i) As reviewed and certified by the Prince George’s County Board
3 of Elections or its designees before the precinct boundaries were reported to the U.S.
4 Bureau of the Census as part of the [2010] **2020** Census Redistricting Data Program; and

5 (ii) As those precinct lines are specifically shown on the Public Law
6 94–171 census block maps provided by the U.S. Bureau of the Census and as reviewed and
7 corrected by the Department of Planning.

8 (2) Where precincts are split between board of education districts, census

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
19 measure, is necessary for the immediate preservation of the public health or safety, has
20 been passed by a yea and nay vote supported by three-fifths of all the members elected to
21 each of the two Houses of the General Assembly, and shall take effect from the date it is
22 enacted.
