1 AN ACT concerning

2 **Washington Suburban Sanitary Commission – Commissioner Qualifications and**
3 **General Manager Voting Powers**

4 **MC/PG 108–23**

5 FOR the purpose of requiring certain qualifications for a certain number of commissioners
6 of the Washington Suburban Sanitary Commission; providing that the general
7 manager of the Washington Suburban Sanitary Commission has certain voting
8 powers; and generally relating to the Washington Suburban Sanitary Commission.

9 BY repealing and reenacting, with amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Public Utilities**

17 17–102.

1 (a) The Commission consists of:

2 (1) three commissioners from Prince George's County, appointed by the
3 County Executive subject to the confirmation of the County Council; and

4 (2) three commissioners from Montgomery County, appointed by the
5 County Executive subject to the confirmation of the County Council.

6 (b) (1) Each commissioner from Prince George's County shall be a resident of
7 the sanitary district.

8 (2) (i) Each commissioner from Montgomery County shall be a
9 registered voter of Montgomery County.

10 (ii) Each commissioner from Prince George's County shall be a
11 registered voter of Prince George's County.

12 **(3) AT LEAST ONE COMMISSIONER FROM EACH COUNTY SHALL HAVE**
13 **AT LEAST ONE OF THE FOLLOWING QUALIFICATIONS:**

14 **(I) 1. A MASTER'S DEGREE, A DOCTORAL DEGREE, OR AN**
15 **EQUIVALENT LEVEL OF EDUCATION DETERMINED IN ACCORDANCE WITH THE 2011**
16 **INTERNATIONAL STANDARD CLASSIFICATION OF EDUCATION; AND**

17 **2. AT LEAST 5 YEARS' EXPERIENCE IN THE**
18 **MANAGEMENT OF A GOVERNMENTAL ENTITY OR BOARD OF DIRECTORS THAT IS**
19 **COMPARABLE TO THE COMMISSION IN SCOPE AND COMPLEXITY;**

20 **(II) EDUCATION IN THE ENVIRONMENTAL SCIENCES; OR**

21 **(III) PROFESSIONAL EXPERIENCE IN UTILITY MANAGEMENT.**

22 (c) (1) An individual may not be appointed or continue in office as a
23 commissioner if the individual holds any other position of profit or trust under the
24 Constitution or laws of the State or any political subdivision of the State.

1 (2) Not more than two commissioners from Montgomery County may be of
2 the same political party.

3 (d) (1) The term of a commissioner is 4 years and begins on June 1 of the year
4 of appointment.

5 (2) The terms of commissioners are staggered as required by the terms
6 provided for commissioners on July 1, 1982.

7 (3) At the end of a term, a commissioner continues to serve until a successor
8 is appointed and takes the oath of office.

9 (4) A commissioner who is appointed after a term has begun serves only for
10 the rest of the term and until a successor is appointed and takes the oath of office.

11 (5) A vacancy on the Commission does not impair the right of the
12 remaining commissioners to exercise all the powers of the Commission.

13 **(E) THE GENERAL MANAGER OF THE COMMISSION HAS THE SAME VOTING**
14 **POWERS AS THE COMMISSIONERS ON ALL MATTERS BEFORE THE COMMISSION**
15 **EXCEPT REGARDING DECISIONS RELATING TO:**

16 **(1) THE INSPECTOR GENERAL OR THE SECRETARY; OR**

17 **(2) THE SALARY OF THE GENERAL MANAGER, THE INSPECTOR**
18 **GENERAL, OR THE SECRETARY.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2023.
