5 FOR the purpose of authorizing Prince George’s County or a municipal corporation in
6 Prince George’s County to create certain business improvement districts; requiring
7 the county or a municipal corporation in the county to adopt certain local laws to
8 provide for the creation and organization of a district; providing for the imposition of
9 a certain tax in a certain manner under certain circumstances; removing Prince
10 George’s County from the scope of law governing the establishment of business
11 improvement districts; and generally relating to business improvement districts and
12 district corporations in Prince George’s County.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That the Laws of Maryland read as follows:

13 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
14 INDICATED.

15 (B) “BOARD” MEANS THE BOARD OF DIRECTORS OF A DISTRICT
16 CORPORATION.

17 (C) “COMMERCIAL TENANT” MEANS A LESSEE OR OTHER LAWFUL
18 OCCUPANT, OTHER THAN THE OWNER, OF NONEXEMPT PROPERTY WITHIN A
19 DISTRICT.

20 (D) “CONDOMINIUM” HAS THE MEANING STATED IN § 11–101 OF THE REAL
21 PROPERTY ARTICLE.

22 (E) “COOPERATIVE HOUSING CORPORATION” HAS THE MEANING STATED IN
23 § 5–6B–01 OF THE CORPORATIONS AND ASSOCIATIONS ARTICLE.

24 (F) “DISTRICT” MEANS A BUSINESS IMPROVEMENT DISTRICT ESTABLISHED
25 UNDER THIS SUBTITLE.

1 **(G) “DISTRICT CORPORATION” MEANS A BUSINESS IMPROVEMENT**
2 **DISTRICT CORPORATION FORMED IN ACCORDANCE WITH THIS SUBTITLE.**

3 **(H) “FORMATION STEERING COMMITTEE” MEANS THE GROUP OF**
4 **STAKEHOLDERS RESPONSIBLE FOR LEADING THE FORMATION OF A DISTRICT AND**
5 **PREPARING THE APPLICATION IN ACCORDANCE WITH § 12-908 OF THIS SUBTITLE.**

6 **(I) “HOMEOWNERS ASSOCIATION” HAS THE MEANING STATED IN § 11B-101**
7 **OF THE REAL PROPERTY ARTICLE.**

8 **(J) “MEMBERS OF THE DISTRICT” MEANS OWNERS OF NONEXEMPT**
9 **PROPERTY, COMMERCIAL TENANTS, AND RESIDENTS IN THE DISTRICT.**

10 **(K) “NONEXEMPT PROPERTY” MEANS ALL REAL PROPERTY THAT IS NOT**
11 **EXEMPT FROM PAYING REAL PROPERTY TAXES EXCEPT:**

12 **(1) CONDOMINIUM UNITS AND COOPERATIVE HOUSING**
13 **CORPORATION UNITS THAT EXIST ON OR BEFORE THE DATE OF ESTABLISHMENT OF**
14 **A DISTRICT;**

15 **(2) HOMEOWNERS ASSOCIATIONS; OR**

16 **(3) RESIDENTIAL PROPERTY WITH FEWER THAN FOUR DWELLING**
17 **UNITS.**

18 **(L) “RESIDENT” MEANS AN INDIVIDUAL WHOSE PRIMARY RESIDENCE IS**
19 **WITHIN A DISTRICT, INCLUDING A RENTER OR AN OWNER OF RESIDENTIAL**
20 **PROPERTY, REGARDLESS OF WHETHER THE INDIVIDUAL RESIDES ON NONEXEMPT**
21 **PROPERTY OR EXEMPT PROPERTY.**

23 **THE LEGISLATIVE PURPOSES OF THIS SUBTITLE ARE TO:**

24 **(1) PROVIDE FOR THE CREATION OF BUSINESS IMPROVEMENT**
25 **DISTRICTS WITHIN PRINCE GEORGE’S COUNTY; AND**

26 **(2) PROMOTE THE GENERAL WELFARE OF THE RESIDENTS,**

1 EMPLOYERS, EMPLOYEES, PROPERTY OWNERS, COMMERCIAL TENANTS,
2 CONSUMERS, AND THE GENERAL PUBLIC WITHIN THE GEOGRAPHIC AREA OF THE
3 BUSINESS IMPROVEMENT DISTRICTS.

7 (A) SUBJECT TO A PUBLIC HEARING UNDER § 12-909 OF THIS SUBTITLE

9 SUBTITLE, THE GOVERNING BODY OF THE COUNTY OR A MUNICIPAL CORPORATION
10 IN THE COUNTY MAY ADOPT A LOCAL LAW TO CREATE A BUSINESS IMPROVEMENT
11 DISTRICT IN ACCORDANCE WITH THIS SUBTITLE.

12 (B) SUBSECTION (A) OF THIS SECTION IS SELF-EXECUTING AND FULLY
13 AUTHORIZES THE COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY TO
14 ESTABLISH A DISTRICT, NOTWITHSTANDING ANY OTHER STATUTORY OR CHARTER
15 PROVISION.

16 (C) A LOCAL LAW ADOPTED UNDER SUBSECTION (A) OF THIS SECTION
17 SHALL INCLUDE:

- 19 (2) THAT THE DISTRICT CORPORATION IS FORMED UNDER THIS
20 SUBTITLE;
- 21 (3) THE NAMES, ADDRESSES, AND TERMS OF OFFICE OF THE INITIAL
22 MEMBERS OF THE BOARD OF DIRECTORS OF THE DISTRICT CORPORATION;
- 23 (4) THE ADDRESS OF THE PRINCIPAL OFFICE OF THE DISTRICT
24 CORPORATION;
- 25 (5) THE PURPOSES FOR WHICH THE DISTRICT IS FORMED;
- 26 (6) THE POWERS OF THE DISTRICT, SUBJECT TO THE LIMITATIONS ON

1 THE POWERS OF DISTRICTS UNDER THIS SUBTITLE; AND

5 (A) A BOARD OF DIRECTORS SHALL GOVERN THE DISTRICT CORPORATION.

6 (B) (1) SUBJECT TO PARAGRAPHS (2) THROUGH (4) OF THIS
7 SUBSECTION:

8 (I) EXCEPT AS PROVIDED IN ITEM (II) OF THIS PARAGRAPH,
9 THE BOARD OF A DISTRICT CORPORATION CONSISTS OF AT LEAST NINE MEMBERS;
10 OR

11 (II) THE GOVERNING BODY OF THE COUNTY OR A MUNICIPAL
12 CORPORATION IN THE COUNTY IN WHICH A DISTRICT IS ESTABLISHED MAY
13 DETERMINE A DIFFERENT NUMBER OF MEMBERS FOR THE BOARD IF THE DISTRICT
14 IS CONNECTED WITH A BUSINESS IMPROVEMENT DISTRICT IN ANOTHER COUNTY OR
15 STATE OR IN THE DISTRICT OF COLUMBIA.

16 (2) (I) THE BOARD SHALL BE REPRESENTATIVE OF PROPERTY
17 OWNERS, BUSINESS OWNERS, RESIDENTS, AND REPRESENTATIVES OF THE LOCAL
18 JURISDICTIONS WITHIN THE BOUNDARIES OF THE BUSINESS IMPROVEMENT
19 DISTRICT.

20 (II) IT SHALL BE THE RESPONSIBILITY OF THE INITIAL BOARD
21 OF THE BUSINESS IMPROVEMENT DISTRICT TO DETERMINE IN THE DISTRICT'S
22 BYLAWS THE SPECIFIC DETAILS PERTAINING TO BOARD STRUCTURE, INCLUDING
23 THE SPECIFIC NUMBER OF POSITIONS, TERMS, AND VOTING PROCEDURES.

24 (3) THE BOARD SHALL RETAIN AS NONVOTING MEMBERS THE
25 MEMBER OF THE SENATE OF MARYLAND AND MEMBERS OF THE HOUSE OF
26 DELEGATES WHO REPRESENT THE LEGISLATIVE DISTRICT WHERE A DISTRICT
27 CORPORATION IS ESTABLISHED.

28 (4) (I) BOARD SEATS SHALL BE ELECTED IN ACCORDANCE WITH AN

1 ELECTION PROCESS THAT IS ESTABLISHED BY THE GOVERNING BODY OF THE
2 COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY WHERE THE DISTRICT IS
3 LOCATED.

4 (II) TO THE EXTENT PRACTICABLE, THE ELECTION PROCESS
5 SHALL REFLECT THE DIVERSITY OF BUSINESSES AND OTHER ORGANIZATIONS IN
6 THE DISTRICT.

7 (C) FROM AMONG ITS MEMBERS, THE BOARD SHALL ELECT A CHAIR AND
8 OTHER OFFICERS.

9 (D) (1) A MAJORITY OF THE VOTING MEMBERS OF THE BOARD IS A
10 QUORUM.

11 (2) THE BOARD MAY ACT ON A RESOLUTION ONLY BY THE
12 AFFIRMATIVE VOTE OF A MAJORITY OF THE VOTING MEMBERS.

13 (E) A MEMBER OF THE BOARD:

14 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;
15 BUT

16 (2) SHALL BE REIMBURSED FOR EXPENSES INCURRED IN
17 PERFORMING THE MEMBER'S DUTIES.

18 (F) THE BOARD SHALL EXERCISE ITS POWERS BY RESOLUTION.

19 (G) THE BOARD SHALL FILE AN ANNUAL REPORT WITH THE GOVERNING
20 BODY OF THE COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY THAT
21 INCLUDES:

22 (1) A FINANCIAL STATEMENT FOR THE PRECEDING YEAR;

23 (2) A PROPOSED OPERATING BUDGET FOR THE CURRENT FISCAL
24 YEAR;

25 (3) ANY PROPOSED REVISIONS TO THE BUSINESS PLAN; AND

1 **(4) A NARRATIVE STATEMENT OR CHART SHOWING THE RESULTS OF**
2 **OPERATIONS IN COMPARISON TO STATED GOALS AND OBJECTIVES.**

4 **THE NET EARNINGS OF A DISTRICT CORPORATION MAY BENEFIT ONLY THE**
5 **DISTRICT CORPORATION.**

6 **12-907.**

7 **(A) (1) EXCEPT AS LIMITED BY ITS ARTICLES OF INCORPORATION, A**
8 **DISTRICT CORPORATION HAS ALL THE POWERS SET FORTH IN THIS SUBTITLE.**

9 **(2) A DISTRICT CORPORATION MAY:**

10 **(I) RECEIVE MONEY FROM ITS INCORPORATING COUNTY OR**
11 **MUNICIPAL CORPORATION, THE STATE, OTHER GOVERNMENTAL UNITS, OR**
12 **NONPROFIT ORGANIZATIONS;**

13 **(II) CHARGE FEES FOR ITS SERVICES;**

14 **(III) HAVE EMPLOYEES AND CONSULTANTS AS THE DISTRICT**

16 **(IV) USE THE SERVICES OF OTHER GOVERNMENTAL UNITS.**

10 **PROPERTY AND TO THE EXTENT REASONABLY ASCERTAINABLE, EACH COMMERCIAL**
11 **TENANT WITHIN THE PROPOSED DISTRICT;**

12 **(2) A STATEMENT EXPRESSING THE INTENT TO ESTABLISH A**
13 **DISTRICT CORPORATION THAT IS SIGNED BY OWNERS OF AT LEAST 51% OF THE**
14 **TOTAL NUMBER OF PARCELS OF NONEXEMPT PROPERTY AND, SUBJECT TO**
15 **SUBSECTION (C) OF THIS SECTION, A DESIGNATED BOARD MEMBER OF A**
16 **CONDOMINIUM OR COOPERATIVE HOUSING CORPORATION WITHIN THE PROPOSED**
17 **DISTRICT;**

18 **(3) A PROPOSED 5-YEAR BUSINESS PLAN THAT CONTAINS:**

19 **(I) THE GOALS AND OBJECTIVES OF THE PROPOSED DISTRICT;**

20 **(II) THE ANNUAL PROPOSED BUSINESS IMPROVEMENT**
21 **DISTRICT TAX FOR THE PROPOSED DISTRICT'S COMMON OPERATIONS AND THE**
22 **FORMULA USED TO DETERMINE EACH MEMBER'S DISTRICT TAX; AND**

23 **(III) THE MAXIMUM AMOUNT AND THE NATURE OF START-UP**
24 **COSTS INCURRED BEFORE THE DISTRICT'S ESTABLISHMENT;**

25 **(4) A TAX ASSESSOR'S MAP OF THE GEOGRAPHIC AREA OF THE**
26 **PROPOSED DISTRICT;**

27 **(5) A LIST OF THE PROPOSED INITIAL BOARD OF THE PROPOSED**

1 DISTRICT CORPORATION;

2 (6) THE PROPOSED ARTICLES OF INCORPORATION AND THE BYLAWS
3 OF THE DISTRICT CORPORATION; AND

4 (7) FOR ALL NONEXEMPT PROPERTY WITHIN THE PROPOSED

8 (A) AT LEAST 21 CALENDAR DAYS BEFORE THE PUBLIC HEARING, THE
9 GOVERNING BODY OF THE COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY
10 SHALL PUBLISH NOTICE OF THE PUBLIC HEARING IN A NEWSPAPER OF GENERAL
11 CIRCULATION WITHIN THE GEOGRAPHIC AREA OF THE PROPOSED DISTRICT.

20 DISTRICT.

21 (C) BEFORE THE PUBLIC HEARING, THE APPLICATION SHALL BE MADE
22 AVAILABLE FOR REVIEW DURING NORMAL BUSINESS HOURS IN AT LEAST ONE
23 LOCATION IN THE PROPOSED DISTRICT.

24 (D) WITHIN 10 CALENDAR DAYS AFTER THE PUBLIC HEARING, IF THE
25 GOVERNING BODY OF THE COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY
26 DETERMINES, IN THE SOLE DISCRETION OF THE GOVERNING BODY, THAT THE NEEDS
27 OF THE DISTRICT MEET A PURPOSE OF THIS SUBTITLE, THE GOVERNING BODY MAY

1 **(A) WITHIN 10 CALENDAR DAYS AFTER THE AUTHORIZATION OF THE**
2 **DISTRICT BY THE GOVERNING BODY OF THE COUNTY OR A MUNICIPAL**
3 **CORPORATION IN THE COUNTY, THE DISTRICT CORPORATION SHALL PROVIDE THE**
4 **GOVERNING BODY OF THE COUNTY OR A MUNICIPAL CORPORATION IN THE COUNTY**
5 **WITH A PRELIMINARY BUSINESS IMPROVEMENT DISTRICT TAX ROLL.**

1 **(A) THE GOVERNING BODY OF THE COUNTY OR A MUNICIPAL CORPORATION**

4 **(1) REVIEW THE EFFECTIVENESS AND DESIRABILITY OF CONTINUING**
