2 **Prince George’s County – Sales and Use Tax on Telecommunications Services –**
3 **Use of Revenue**

5 FOR the purpose of altering a certain provision of law relating to the use of certain revenue
6 from the sales and use tax on telecommunications services in Prince George’s County
7 by allowing the revenue to be used to meet certain education funding requirements
8 for the county; and generally relating to the sales and use tax on telecommunications
9 services in Prince George’s County and county funding requirements in primary and
10 secondary education.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That the Laws of Maryland read as follows:

9 **Article – Education**

10 5–235.

11 (a) (1) (i) Subject to subsection (o) of this section and beginning in fiscal
12 year 2023, the county governing body shall levy and appropriate an annual tax sufficient
13 to provide an amount of revenue for elementary and secondary public education purposes
14 equal to the local share of major education aid as adjusted under § 5–239 of this subtitle.

15 (ii) For the purposes of calculating the local share of major education
16 aid and regardless of the source of the funds, all funds that a county board, including the
17 Baltimore City Board of School Commissioners, is authorized to expend for schools may be
18 considered as levied by the county council, board of county commissioners, or the Mayor
19 and City Council of Baltimore except for:

- 20 1. State appropriations;
- 21 2. Federal education aid payments; and
- 22 3. The amount of the expenditure authorized for debt service
23 and capital outlay.

24 (2) Subject to subsection (o) of this section and except as provided in
25 subsection (a–1) of this section, the county governing body shall appropriate local funds to
26 the school operating budget in an amount no less than the product of the county’s
27 enrollment count for the current fiscal year and the local appropriation on a per pupil basis
28 for the prior fiscal year using enrollment count.

(b) (1) Except as otherwise provided in this section, the sales and use tax imposed under this section applies to telecommunications service that:

(i) originates and terminates in Prince George’s County; or

(ii) originates or terminates in Prince George’s County and has a service address in Prince George’s County.

(c) By ordinance, the County Council for Prince George’s County shall impose a sales and use tax on telecommunications service in Prince George’s County at a rate not less than 5%.

(e) (1) The net proceeds of the revenue from the tax imposed under this section shall be used as follows:

(i) at least 90% of the net proceeds shall be used for operating expenditures for the Prince George’s County school system; and

(ii) the remainder shall be used for:

1. cash payments for capital expenditures for school renovation projects approved by the Prince George’s County Board of Education and Prince George’s County; or

2. payment of debt service on bonds issued by the governing body of Prince George’s County for school renovation projects approved by the Prince George’s County Board of Education and Prince George’s County.

(2) The proceeds provided under this section for the Prince George’s County school system may [not] be used to [supplant:

(i) any State aid for education provided to Prince George’s County;

or

1 (ii) any county funds provided to the Prince George’s County school
2 system] **MEET THE COUNTY’S FUNDING REQUIREMENTS UNDER § 5–235(A) OF THE**
3 **EDUCATION ARTICLE.**

4 (4) On or before December 31 of each year, the governing body of Prince
5 George’s County shall submit a report detailing the expenditure of revenues generated from
6 the tax imposed under this section to the Department of Legislative Services, the Prince
7 George’s County school system, and the Prince George’s County Delegation of the General
8 Assembly.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2024.
