A BILL ENTITLED

1 AN ACT concerning

2 **Prince George’s County – Speed Monitoring Systems – Maryland Route 210**

3 **PG 306–25**

4 FOR the purpose of increasing civil penalties for violations recorded by speed monitoring
5 systems on Maryland Route 210 (Piscataway Highway) in Prince George’s County
6 that are second or subsequent violations or that involve exceeding the maximum
7 speed limit by certain amounts; repealing the termination provision for the authority
8 to place speed monitoring systems on Maryland Route 210 (Piscataway Highway) in
9 Prince George’s County; and generally relating to speed monitoring systems on
10 Maryland Route 210 (Piscataway Highway) in Prince George’s County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Transportation**

4 21–809.

5 (c) (1) Unless the driver of the motor vehicle received a citation from a police
6 officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this
7 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is
8 recorded by a speed monitoring system while being operated in violation of this subtitle.

9 (2) (I) **[A] EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
10 **PARAGRAPH, A civil penalty under this subsection may not exceed \$40.**

11 (II) 1. **THIS SUBPARAGRAPH APPLIES TO A CIVIL PENALTY**
12 **ASSESSED TO THE OWNER OR DRIVER OF A MOTOR VEHICLE THAT IS RECORDED BY**
13 **A SPEED MONITORING SYSTEM WHILE BEING OPERATED ON MARYLAND ROUTE 210**
14 **(PISCATAWAY HIGHWAY) IN PRINCE GEORGE’S COUNTY IN VIOLATION OF THIS**
15 **SUBTITLE.**

16 2. **SUBJECT TO SUBSUBPARAGRAPH 3 OF THIS**
17 **SUBPARAGRAPH, A CIVIL PENALTY UNDER THIS SUBPARAGRAPH IS AS FOLLOWS:**

18 A. **FOR EXCEEDING THE MAXIMUM POSTED SPEED LIMIT**
19 **BY BETWEEN 12 AND 15, INCLUSIVE, MILES PER HOUR, \$60;**

20 B. **FOR EXCEEDING THE MAXIMUM POSTED SPEED LIMIT**
21 **BY BETWEEN 16 AND 19, INCLUSIVE, MILES PER HOUR, \$80;**

22 C. **FOR EXCEEDING THE MAXIMUM POSTED SPEED LIMIT**
23 **BY BETWEEN 20 AND 29, INCLUSIVE, MILES PER HOUR, \$140;**

24 D. **FOR EXCEEDING THE MAXIMUM POSTED SPEED LIMIT**
25 **BY BETWEEN 30 AND 39, INCLUSIVE, MILES PER HOUR, \$270; OR**

26 E. **FOR EXCEEDING THE MAXIMUM POSTED SPEED LIMIT**

1 BY 40 MILES PER HOUR OR MORE, \$500.

2 3. THE OWNER OR DRIVER OF A MOTOR VEHICLE
3 RECORDED BY A SPEED MONITORING SYSTEM IN VIOLATION OF THIS SUBTITLE IS
4 SUBJECT TO THE FOLLOWING ADDITIONAL CIVIL PENALTIES:

5 A. FOR A SECOND VIOLATION WITHIN A 2-YEAR PERIOD,
6 \$50;

7 B. FOR A THIRD VIOLATION WITHIN A 2-YEAR PERIOD,
8 \$150;

9 C. FOR A FOURTH VIOLATION WITHIN A 2-YEAR PERIOD,
10 \$250;

11 D. FOR A FIFTH VIOLATION WITHIN A 2-YEAR PERIOD,
12 \$300; AND

13 E. FOR A SIXTH OR SUBSEQUENT VIOLATION WITHIN A
14 2-YEAR PERIOD, \$350.

15 (3) For purposes of this section, the District Court shall prescribe:

16 (i) A uniform citation form consistent with subsection (d)(1) of this
17 section and § 7-302 of the Courts Article; and

18 (ii) A civil penalty, which shall be indicated on the citation, to be paid
19 by persons who choose to prepay the civil penalty without appearing in District Court.

20 **Chapter 806 of the Acts of 2018, as amended by Chapter 606 of the Acts of 2023**

21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2018. [It shall remain effective for a period of 10 years and, at the end of
23 September 30, 2028, this Act, with no further action required by the General Assembly,
24 shall be abrogated and of no further force and effect.]

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2025.
