A BILL ENTITLED

1 AN ACT concerning

2 **State Highway Administration – Memorials – Maryland Route 210 in Prince**  
3 **George’s County**

4 **PG 307–25**

5 FOR the purpose of requiring the State Highway Administration to erect a memorial sign  
6 on a certain portion of Maryland Route 210 in Prince George’s County remembering  
7 individuals who have died in motor vehicle accidents on Maryland Route 210; and  
8 generally relating to a memorial remembering individuals who have died in motor  
9 vehicle accidents on Maryland Route 210.

10 BY repealing and reenacting, with amendments,  
11 Article – Transportation  
12 Section 8–663  
13 Annotated Code of Maryland  
14 (2020 Replacement Volume and 2024 Supplement)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

2 (A) The Administration shall designate Maryland Route 210 as the Piscataway  
3 Highway.

4 (B) (1) **THE ADMINISTRATION SHALL ERECT A MEMORIAL SIGN ALONG**  
5 **THE PORTION OF MARYLAND ROUTE 210 THAT IS LOCATED BETWEEN MILE**  
6 **MARKERS 11.359 AND 11.672, RAMPS 1 AND 2 TO KERBY HILL ROAD,**  
7 **REMEMBERING INDIVIDUALS WHO HAVE DIED FROM INJURIES SUSTAINED IN**  
8 **MOTOR VEHICLE ACCIDENTS ON MARYLAND ROUTE 210.**

9 (2) **THE MEMORIAL SIGN SHALL:**

10 (i) **BE VISIBLE TO TRAVELERS ON MARYLAND ROUTE 210; AND**

11 (ii) **INCLUDE THE FOLLOWING LANGUAGE:**

12 **“IN MEMORY OF THE LIVES LOST ON MARYLAND ROUTE 210. WE ARE MAKING OUR**  
13 **HIGHWAY SAFER.”.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 October 1, 2025.
