2 day.

3 (3) For a Class D (3–day) beer and wine license, the fee is ~~[\$100]~~ **\$125** per
4 day.

5 (b) (1) Except as provided in paragraph (2) of this subsection, for a Class C per
6 diem beer, wine, and liquor license, the fee is ~~[\$200]~~ **\$225** per day.

7 (2) (i) For a club holding a gaming event, the fee is ~~[\$150]~~ **\$175** per
8 day.

9 (3) For a Class C (3–day) beer, wine, and liquor license, the fee is ~~[\$200]~~
10 **\$225** per day.

12 (a) The Board shall charge an application fee for a new license.

13 (c) The application fee is ~~[\$300]~~ **\$400** and in addition to any other fee required
14 for a license.

17 liquor license with an off–sale privilege for use in Hyattsville.
