2 **Prince George’s County Teen Pregnancy Support Program and Fee in Child**
3 **Support Cases – Established**

5 FOR the purpose of establishing the Prince George’s County Teen Pregnancy Support
6 Program to provide certain students attending a public high school in Prince
7 George’s County with certain assistance relating to child care and parenting;
8 requiring the Circuit Court for Prince George’s County to collect a certain fee in
9 certain cases pertaining to child support; requiring the revenue generated from the
10 fee to be remitted to the Prince George’s County Board of Education and used to
11 support the Prince George’s County Teen Pregnancy Support Program in the county;
12 and generally relating to the Prince George’s County Teen Pregnancy Support
13 Program.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That the Laws of Maryland read as follows:

7 **Article – Education**

8 **3–1009.**

9 **(A) THERE IS A PRINCE GEORGE’S COUNTY TEEN PREGNANCY SUPPORT**
10 **PROGRAM.**

11 **(B) THE PRINCE GEORGE’S COUNTY BOARD SHALL ASSIST STUDENTS WHO**
12 **ARE EXPECTING TO BECOME, OR HAVE BECOME, A PARENT TO A CHILD WHILE**
13 **ATTENDING A PUBLIC HIGH SCHOOL IN THE COUNTY BY PROVIDING TO STUDENTS:**

14 **(1) CASH VOUCHERS TO ASSIST IN PAYING FOR CHILD CARE**
15 **EXPENSES;**

16 **(2) PARENTING EDUCATION; AND**

17 **(3) OTHER RESOURCES THAT SUPPORT FIRST–TIME PARENTS.**

18 **(C) THE PRINCE GEORGE’S COUNTY BOARD SHALL:**

19 **(1) ESTABLISH PROCEDURES FOR PROVIDING THE SUPPORT**
20 **DESCRIBED UNDER SUBSECTION (B) OF THIS SECTION; AND**

21 **(2) USE THE REVENUE FROM THE FEES COLLECTED AND REMITTED**
22 **UNDER § 12–103.1 OF THE FAMILY LAW ARTICLE TO FUND THE SUPPORT**
23 **DESCRIBED UNDER SUBSECTION (B) OF THIS SECTION.**

24 **Article – Family Law**

25 **12–103.1.**

1 **(A) THIS SECTION APPLIES ONLY IN PRINCE GEORGE’S COUNTY.**

2 **(B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE COURT IN**
3 **PRINCE GEORGE’S COUNTY SHALL COLLECT A FEE OF \$100 IN ANY CASE IN WHICH**
4 **AN INDIVIDUAL:**

5 **(1) APPLIES FOR A DECREE OR MODIFICATION OF A DECREE OF CHILD**
6 **SUPPORT; OR**

7 **(2) FILES ANY FORM OF PROCEEDING TO RECOVER ARREARAGES OF**
8 **OR TO ENFORCE A DECREE OF CHILD SUPPORT.**

9 **(C) THE REVENUE GENERATED FROM THE FEES COLLECTED UNDER THIS**
10 **SECTION SHALL BE REMITTED QUARTERLY TO THE PRINCE GEORGE’S COUNTY**
11 **BOARD OF EDUCATION AND USED TO SUPPORT THE PRINCE GEORGE’S COUNTY**
12 **TEEN PREGNANCY SUPPORT PROGRAM ESTABLISHED UNDER § 3-1009 OF THE**
13 **EDUCATION ARTICLE.**

14 **(D) THE FEE IMPOSED UNDER THIS SECTION IS IN ADDITION TO ANY OTHER**
15 **FEES OR COSTS IMPOSED UNDER LAW, REGULATION, OR RULE.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
17 1, 2026.
